## **Call for Art: Good Coffee Roasting Company in Polson**

*Good Coffee Roasting Company and Sandpiper Art Gallery and Gifts invite Flathead County, Lake County, and Missoula County artists to paint murals on the rear exterior wall of Good Coffee at 214 Main St, Polson, plus 25% of the adjacent back wall. This Public Art Project benefits Polson by creating an inclusive, creative environment that fosters a sense of community and appreciation of art.*

- The artists are invited to take the viewer on a visual journey by creating murals that shows a reimagination of a natural Montana landscape—its flora, fauna, and terrain—through the lens of the coffee culture.
- While the scene should remain rooted in the beauty and authenticity of Montana's wilderness, select natural elements must be creatively substituted with coffee-related items.
- These could include beans, cups, brewing tools, or other symbolic references to coffee, seamlessly integrated into the environment. Artists should think about including the farming that occurs in the area, especially cherries.
- The goal is to create a harmonious yet imaginative fusion of nature and café culture.
- Above all the fun elements of this mural will be the words, 'DOWNTOWN POLSON'. These letters will be large enough to be readable from highway 93. The artist needs to continue their design to wrap around to the adjacent side, (the back wall) so that all of the brown wall above the stairway is painted with a mural.

The Artist chosen will have designs for the wall that follows the theme of the project, 'Brewing in the Backcountry'.

The selected artist will work with the Sandpiper Research and Development Committee to organize Polson volunteers to help complete the murals. The artist is responsible for the accurate layout of their designs and facilitating Polson volunteers to help complete the mural in a timely manner so that they will be ready for “Let’s Make Art Week”. Artists are expected to be present during that week of **June 8-13** and will work alongside volunteers from 10am-4pm every day.

## **Artists Award and Eligibility**

- Artists must reside in Flathead County, Lake County, and Missoula County
- Applicants will be chosen regardless of race, color, religion, creed, political ideas, age, marital status, physical or mental disability, national origin, familial status, sexual orientation and gender identity or expression.

## **Design Criteria**

- Designs should follow mural theme “Brewing in The Backcountry”
- Designs should use colors of an appropriate palette and have a focal point and use diagonals.
- Designs may not include advertisements, business promotion, or trademarks/brands/images of illegal acts.
- Designs compliment the building. Artists should view the building before designing.

## **Selection Process**

- Because public art reflects its community, The Good Coffee Roasting Company and Sandpiper Art Gallery and Gifts expects high quality submissions of concept. The Project Coordinator will ensure durability and safety of paint application.
- The Good Coffee Roasting Company and Sandpiper Art Gallery and Gifts Selection Team will review applications and choose award recipients.

## **Application Information**

- Artists are required to provide proof of medical insurance. Sandpiper's policy covers the first \$15000 of any medical claims.
- Artists must use high quality exterior matte paint.
- Artists are responsible for any materials including a lift rental and/or scaffolding.
- Artists should prepare a graphic design or artwork that:
  - Is colored.
  - Is minimum 32 square inches and accurately depicts the size/proportion of the project.
  - Includes the artist's name, title of work, and contact information on the inside or bottom of the design.
  - Applications should include a brief bio and examples of previous work, particularly showing painting of larger artworks.
