## **Call for Art: 1-800 Water Damage of Western Montana in Polson**

The 1-800 Water Damage of Western Montana and the Sandpiper Art Gallery and Gifts, invites Flathead County, Lake County, and Missoula County artists, (to paint murals on the exterior building, 401 Main Street, including 4 x niches and the side wall next to the furniture store. This Public Art Project benefits Polson by creating an inclusive, creative environment that fosters a sense of community and appreciation of art.

The artists are invited to take the viewer on a visual journey by creating murals, that show the secret lives of black bears that live deep in the ferny mossy forests of Montana, where creeks run through and small creatures like butterflies, hummingbirds, moths and other small critters cohabitate with the mushrooms and fungi. Renditions that are more realistic will be favored.

The Artist chosen will have designs for the building that follows the theme of the project, "The Secret Lives of Black Bears in Montana". The selected artist will work with the Sandpiper Research and Development Committee to organize Polson volunteers to help complete the murals. The artist is responsible for the accurate layout of their designs and facilitating Polson volunteers to help complete the mural in a timely manner so that they will be ready for "Let's Make Art Week". Artists are expected to be present during that week of **June 8-13** and will work alongside volunteers from 10am-4pm every day.

## **Artists Award and Eligibility**

- Artists must reside in Flathead County, Lake County, and Missoula County.
- Applicants will be chosen regardless of race, color, religion, creed, political ideas, age, marital status, physical or mental disability, national origin, familial status, sexual orientation and gender identity or expression.

## **Design Criteria**

- Designs should follow mural theme “The Secret Lives of Black Bears in Montana.”
- Designs should use colors of an appropriate palette and have a focal point and use diagonals.
- Designs may not include advertisements, business promotion, or trademarks/brands/images of illegal acts.
- Designs compliment the building. Artists should view the building before designing.
- Artists must use high quality exterior matt paint.

## **Selection Process**

- Because public art reflects its community, 1-800 Water Damage of Western Montana and Sandpiper Art Gallery and Gifts expects high quality submissions of concept. The Project Coordinator will ensure durability and safety of paint application.
- The 1-800 Water Damage of Western Montana and Sandpiper Art Gallery and Gifts Selection Team will review applications and choose award recipients.

## Application Information

- Artists are required to provide proof of medical insurance, Sandpiper's policy covers the first \$15000 of any medical claims.
- Artists must use high quality exterior matt paint.
- Artists are responsible for any materials including a lift rental and/or scaffolding.
- Artists should prepare a graphic design or artwork that:
  - Is colored.
  - Is minimum 32 square inches and accurately depicts the size/proportion of the project.
  - Includes the artist's name, title of work, and contact information on the inside or bottom of the design.
  - Applications should include a brief bio and examples of previous work, particularly showing painting of larger artworks.

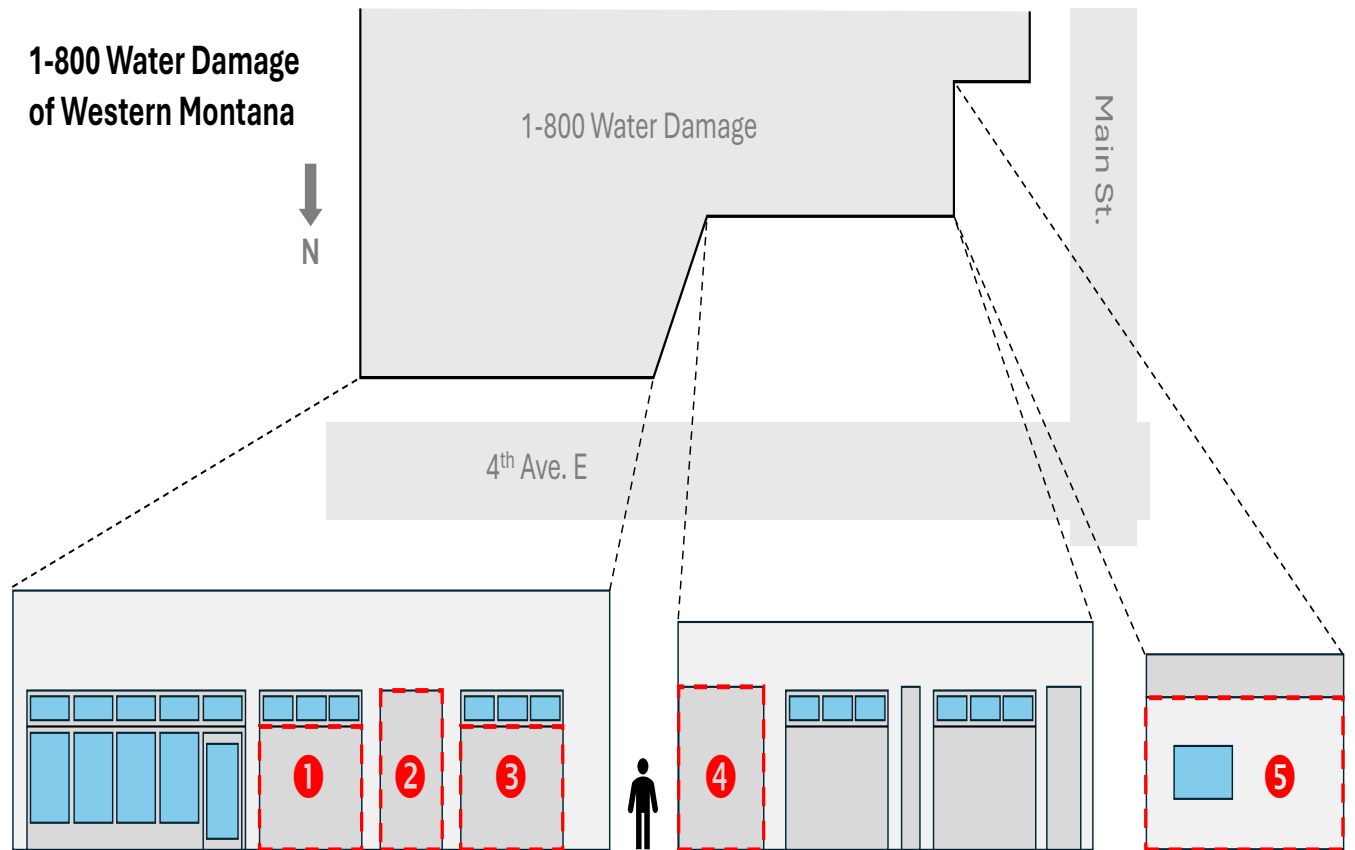
