## TREASURE REPORT

No non-profit status is recognized by the new Simple Cosign. Don was able to get a reduced rate for our credit card fees lowering the rate to 2% plus the .38 cent fee.

#### Festival Director - Carole Carberry

- Banner over Hwy 93 is complete. SAG's portion is \$216. Waiting for payments from the Car Club and the Rotary for the banner.
- Advertising to date has been about \$950.
- Article about the shows will be in the July issue of Living on Flathead Lake
- Will be contacting Anderson broadcasting for a package leading up to each show.
- FLFA which runs July 20 -21 has 43 booths with 2 on a waitlist.
- Courthouse Festival which runs August 10 has 74 booths at this time.
- Signup sheets for volunteers for both festivals are back by the work calendar.
- Festival Posters and postcards have been delivered.
- Press release written and will start to distribute

## Gift Shop Director – Kat Collins

- Kat Collins thanked Sue, Wendy, and Judy for their help with her transition into this position.
- Changes are being made to the gallery. These will make the art more visible.
- Transparent wire has replaced the chains in the front window. An email will be sent out to all members about how to remove stain glass from the wire.
- Kat will look into the cost of getting tempered glass for the heavier pottery items.
- All pieces will be rotated to increase the appeal of the gallery.
- More authors are being brought into the gallery, so a redesign of the book area is planned.

- Policy regarding different levels of membership in the gallery needs to be discussed and rewritten. As the gallery grows should we have "Friends of the Gallery" level for nonartists.
- Discussion was held and a committee will need to look at revisions to the membership.

- Fundraising Art4Polson campaign is going well. Our first mural at Sacagawea park is almost complete. Thanks to all that showed up to help. Ace Hardware donated all of the paint for this project. A sign will be posted stating their involvement and support. Say Thanks next time you are in Ace. A small metal sign will also be placed on the building saying that the Sandpiper Art Gallery and Gifts sponsored this project.
- Annual member meeting was held on May 23 at the library. 25-30 members
  participated. Lots of great suggestions were made. Wendy has complied a workable
  list and R&D will study the list and present new goals for January 2025 and 2026.
- Arranging for a radio announcement of the Sacajawea project and our Art4Polson campaign.
- June 21<sup>st</sup> we should hear about the monetary award from the Great Polson Community Foundation. Call for Art will go out immediately after we receive verification of funds.
- Artists will be given 6 weeks to submit their applications. Department of Transportation has to approve the designs.
- In June an article about the Sandpiper Art Gallery and Gifts was in the Living on Flathead Lake publication. Natalie sent them a thank you.
- Awning application is complete. Judy will need to sign it and submit it to the City of Polson.
- Art4Polson booth will be at both festivals. Dee Dee can you email members again regarding art donations for the booths.
- Fundraising is ongoing with multiple grants still pending.
- Small Art for Big Art is going great and will continue through the summer.
- DeeAnn Richardson has agreed to join the R&D committee. She will bring a great deal
  of knowledge on merchandizing, non-profits and grant writing.
